FA18/474 Other Urgent Business

Randlay Local Centre Car Park area and access concerns

A recent meeting brought together TWC, HRPC, RPS and the contractor to discuss the options for the area. The supply and installation of bollards and boulders would be an advantage to control the drop off points and parking in and around the school and community centre. The quotation would be in two parts, the first being the safety around the school and centre and the cost would be shared between the Parish Council and School. The second would be the updates, one way and no parking areas of the car park. This would be funded by TWC, although accepted it would be re-charged to the Parish Council, School, Pub, Shops & Developer.

The option to use redundant boulders from Homer Lake will be investigated.

It was proposed by Councillor S Vaughan-Hodkinson and seconded by Councillor Unwin that the Parish Council increases the amount already set aside towards the project in order to cover 50% of the cost of 1173.31. All were in favour and thus it Is

RECOMMENDED that 586.65 be made available to cover 50% of the cost of the work outside of the school and community centre.
