# F18/2402 MATTERS ARISING – for information only

#### a) Nighttime Audit

Glyn updated Members on the event to undertake an audit of the street lighting in Hollinswood. A database of issues had been completed and sent to TWC for investigation action.

Councillors S & H Unwin have undertaken a similar audit in Randlay, with only Boulton Grange and Dodmoor Grange still to do. This information will be forwarded to TWC for investigation and action.

#### b) Randlay Local Centre Access and Car Park

The new signs and bollards arrived earlier than planned and the company agreed to install them rather than find a secure place to store them. The white lining and yellow hatched boxes are still be done. The boulders have arrived today. Many positive and favourable comments have been received, but there are still some unhappy parents who now have to park on the car park area.

Areas outside of the school gates and the shops will need more boulders or an alternative way of preventing parking as some parents are now using these as alternative drop-off or pick up points.

## c) New Security System, internal doors at Randlay Community Centre

The new system is now live and has worked well over the weekend and throughout the Christmas Concert. Most groups are finding it much better and feeling safer whilst in the building.

#### d) Redundant roadwork signs

All signs have been collected.

#### e) Randlay Community Centre Main Doors

Two door companies have now confirmed that the door, which was installed by TWC at the time of construction, is not compliant and is outside of the regulations. TWC are now investigating the original specification and will come forward with a solution in the New Year
