A sample of recycled paper was available and recycled pencils and pens are to be considered.

#### F19/2535 PARISH MATTERS

Members reported the following matters for investigation / action

- a) Damaged litter and waste bins. Whilst these are currently being reported, TWC has confirmed that they are undertaking a complete review of bin provision in order to work towards a reduction in the number of bins across the Borough. It is their intention to ensure that the litter picking regime in the new contract will mean that less bins are needed. With regards to the bins in Randlay Valley, which are considered dangerous, in their current condition, TWC will be removing them but will not replace them straight away. They want to see how much litter is collected and therefore assess if the bins are needed or if people will take their litter to the next nearest bin or home.
- b) We still have concerns that the litter is not picked up before grass cutting and where it is shredded, should be picked up after the cutting, so that no dangerous objects remain on the green areas, which could be dangerous for dogs or children.
- c) Councillor Turley shared concerns regarding the statistics relating to Debt & Benefits, particular in The Nedge Ward.
- d) There is a lot of concern about the amount of weedkiller used by the contractors in the new contract – this will be raised at WAC, to see if other Parish Councils have the same concerns.
