C Turley, Chairman, confirmed that the confirmation of the Local Nature Reserve status is nearing completion, following the transfer of the land which was required. Work had been undertaken to ensure that the route, and all relevant risk assessments had been completed in preparation for the upcoming Halloween Event.

There are a number of identified works required, which will form part of the future project plans. Horses are using the new footpath from the car park and it was agreed that the bridleways through The Valley need to be defined and a meeting with Andrew Careless and possibly the nearby Riding Stables may be necessary.

- d) Possible business use within Dunsheath will be reported to TWC for investigation. Vehicle dismantlers are unacceptable due to the anti-social behavior and noise, as well as causing obstruction on the highway and footpaths. The Parish Council will enquire about any need for planning consent.
- e) The draft calendar was available as a hard copy and Members had an opportunity to comment. The final draft will be available before the end of October to ensure an early delivery date. Members are asked to volunteer to deliver in both estates.
