A – Waste contract

B - Mobile Room Divider Boards

It was proposed by Councillor Unwin and seconded by Councillor Dalby, all were in favour and thus it was

RESOLVED that the Parish Council should purchase six sets of 2 boards for use as a room divider at Randlay Community Centre at a reduced cost of £1050.00.

C – Upgrade to LED lights

D - Intruder Alarm, Randlay Community Centre

It was proposed by Councillor Unwin and seconded by Councillor Turley, all were in favour and thus it was

RESOLVED that the Parish Council upgrades the intruder alarm to include a commercial unit with monitoring system at a total cost of £800.

E – Disabled Access Ramp and Handrail at The Pavilion

In order to further enhance the provisions available for SNAC at The Pavilion, it was proposed by Councillor Unwin and seconded by Councillor Dalby, all were in favour and thus it was

RESOLVED that the Parish Council enters into a contract with Bulbs and Ballcocks for the provision of the wooden ramp and handrail. We will request the silver composite decking to offer a disabled access to the SNAC room at the side of the building.

F - Intruder Alarm at The Pavilion

It was proposed by Councillor Unwin and seconded by Councillor Turley, all were in favour and thus it was

RESOLVED that the Parish Council installs a commercial alarm system, with monitoring at The Pavilion at a cost of £1100.

G – Street Light and associated works at The Pavilion

Our electrical contractor has been investigating various options to provide a suitable and affordable street light for the gate area of The Pavilion. The quotations previously received from TWC and the Street Lighting company have been cost prohibitive.

Whilst ascertaining the relevant information, it became clear that emergency work is required at The Pavilion in order for the electrics within the building to become safe. By bringing together the existing order to provide external lights to the building, the upgrading of the system within the building, to provide individual switches for each area within the building and to provide the street light on a dusk to dawn programme, a more cost effective and affordable package has been possible. It was proposed by Councillor Unwin and seconded by Councillor Sinclair, all were in favour and thus it was

RESOLVED that the Parish Council will employ the services of Lime Electrical to provide the electrical works as per the schedule at a total cost of £3037.14 which is within budget.

H - Pavilion Room Hire

Councillors H & S Unwin left the meeting

It was proposed by Councillor Turley and seconded by Councillor Johnson that a threemonth financial package be offered to the afterschool club at The Pavilion, all were in favour and thus it was

RESOLVED that the Parish Council offers a three-month financial package to support the afterschool provision at The Pavilion.
