# FA20/650 Finance & Governance Matters

### a) Revised Budget (August 2020)

The Clerk had reviewed the August 2020 revised budget in detail and updated Members on the current financial position, taking into consideration the drastically reduced income levels for hall hire. As a reminder, the Community Buildings were closed in March and there had been limited hall hire over the Summer.

CONFIRMED that the Revised Budget (August 2020) can continue to operate and support the community as much as is possible in these difficult circumstances.

The Clerk wished to record sincere thanks to all members of staff, who have worked as a team to support the Parish Council in these difficult times. They have often worked additional hours and not expected additional pay, but accepted time off in lieu by negotiation. They support for the community through the Community Support Programme has been appreciated and they have been recognised by TWC and the Lord Lieutenant.

The budget will enable a number of smaller bespoke projects to be undertaken around the Parish, to support the community and enhance the area. It is intended to provide new allotment numbers, regenerated children's amenity spaces within the Estates and colourful planter and basket displays.

# FA20/651 Parish Strategy 21/22 Meetings

Three meetings had taken place (these had replaced the usual Saturday Strategy Meeting) and members were thanked for their input and ideas.

The Chairman explained that the Councillors had considered this year's budget as part of the process for their updated Strategy from 2021/22 to 2024/26 and had agreed not to include additional (new) projects, but rather agree the Council's priorities, taking into consideration the reduced balances and the need to offer a fair and balance budget, with associated precept request, in order to support the community in continued difficult times.

Members shared with the Clerk their thoughts on specific budget headings in order to guide the budget process to prepare an initial draft for the next meeting. Certain decisions had been made and included the inclusion of funds for the LED lighting at RCC, the importance of the continuation of the LMT and provision of the van, maintenance of the Pavilion Field and Muddy (but not necessarily the improvements, unless grant funding is available), the completion of the SID project. Other projects, such as the allotment drainage and solar panels, name signs and electric charging points may only be included if grant funding is available.

The Council is still minded to organise as many of the events as is possible - covid restrictions and funding being taken into consideration. There will be a fun day, and a SNAC activity day,
