PCSO Turley had forwarded a short report to confirm that there have been no further reports regarding off-road bikes and that they continue to support the homeless individuals.

F23/3246 FRIENDS OF HOLLINSWOOD & RANDLAY VALLEY

Councillor Turley, Chairman of FoHRV, updated members on the recent AGM, which although poorly attended, was lively and constructive.

Work has continued in the Valley, as part of the TWC project and has included the extension to the disabled path, steps and handrail from the car park and a handrail for the steps near to the entrance of the bridlepath.

A Walk for Health ramble is to take place on Wednesday, 29th March 2023 – everyone welcome. These take place monthly on the last Wednesday from Hollinswood Pavilion.

We were pleased to hear that Randlay Valley has been designated as a Local Nature Reserve. This is great news and recognition of the excellent work of the Friends of Group – congratulations and thanks to everyone involved. New Interpretation Boards will be designed.

FoHRV will organize a litter pick, with the Scouts, as part of the Great British Spring Clean, this will take place on 1st April. Scouts will also attend on the volunteer day on Tuesday 4th April.

F23/3247 CHAIRMAN'S REPORT

a) Correspondence and Events

The Chairman had attended the recent Royal Visit, when children from Hollinswood & Randlay Primary Schools visited Southwater in Telford to see the arrival of HM Queen Consort, Camilla. It was lovely to see the children waving flags in the sunshine. The Queen Consort visited Southwater to meet representatives of a wide range of voluntary organisations. She also unveiled the plaque for the Telford Veterans Trail.

The Chairman had presented certificates to the young people who helped with the litter pick events in Hollinswood & Randlay.

b) Chairman's Charity

The total raised to date is £1802.82.

Thanks were extended to the staff and councillors who supported the Gymathon and also to Rees, a student from Randlay Primary School, who gave up his time to take part for five hours.

F23/3248 CLERK'S REPORT

a) Hollinswood Flats

The Clerk will represent the Parish Council at a multi-agency meeting on 22nd March, this will be an opportunity for all organisations to share information.

b) Easter Holiday Club

Arrangements are in hand for the four days, with four hours per day of activities and entertainment. This will take place at Randlay Community Centre from 3rd to 6th April.

c) Games Day – 16th August 2023

A grant application had been successful and the Parish Council will receive £2420 from the Safer, Stronger Communities initiative.

d) Randlay Allotments

The drainage appears to be working well. Some plots need attention and arrangements are in hand to visit with the tenants to discuss short, medium and long term plants. The water bills have increased significantly and the income and expenditure need to be carefully monitored. A skip is to be provided and all tenants encouraged to tidy up on and around their plots. Requests for action to improve the car park area had been received and quotations are awaited.

e) TW Play Areas

Members welcomed the refurbishment of the play areas at Boulton Grange and Dallamoor. However, it would have been better if the Parish Council had been informed of the work prior to the start date. Drainage work will be required in Randlay, following the removal of the old equipment.
